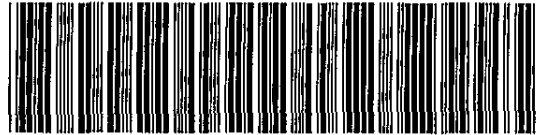

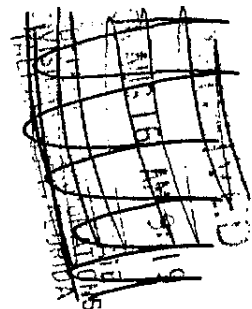

**ARTICLES OF INCORPORATION  
OF

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation is: A YARD YOU'LL LOVE, INC.

**ARTICLE II**

The existence of the Corporation shall begin on: August 20, 2004.

**ARTICLE III**

The street address of the principal office of the Corporation is: 107 NW County Road #235, Alachua, Alachua County, Florida, 32615.
