ARTICLES OF INCORPORATION

The undersigned, competent to contract, for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby makes and subscribes the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation is: J W FLOORING, INC.

ARTICLE II: PRINCIPLE OFFICE

The initial street address of the principle office of this corporation in the State of Florida is: 6213 Terry Parker Drive North, Jacksonville, FL 32211. The Board of Directors may, from time to time, move the principle office to another address within the State of Florida.

ARTICLE III: PURPOSE

The corporation may engage in any activity or business which is permitted under the laws of the United States and of the State of Florida, all for pecuniary gain; except that the corporation is not to conduct a banking, safe deposit, trust, insurance, surety, railroad, canal, a telegraph and telephone or cemetery company, a building and loan association, a mutual fire insurance association, a cooperative association, a fraternal benefit society, a state fair, or an exposition.

ARTICLE IV: SHARES

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is one thousand (1000) shares of common stock with a par value of One Dollar (\$1.00) per share. The consideration to be paid for each share shall be fixed by the Board of Directors. The stock so issued shall be fully paid and non-assessable.

ARTICLE V: INITIAL OFFICERS AND/OR DIRECTORS

This corporation shall have not less than one (1) director. The number of directors may be increased or diminished from time to time by the Bylaws but shall never be less than one. The name, address and title of the first Board of Directors are:

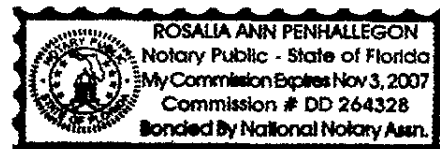
