The Articles of Incorporation of the undersigned corporation were originally filed on August 23, 2004 and assigned document number P04000121650. Pursuant to the authority of Florida's Professional Service Corporation and Limited Liability Company Act and §607.1003 and §607.1006 of the Florida Business Corporation Act, the undersigned professional corporation adopts the following Articles of Amendment to its Articles of Incorporation (these "Articles of Amendment"):

1. The name of the corporation is Bonita Springs Dental Care, P.A. (the "Corporation").

2. "Article 1. Name" of the Articles of Incorporation of the Corporation is amended and restated in its entirety to read as follows:

"Article 1. Name

The name of the Corporation is:

Eck Management, Inc."

3. "Article 3. Purposes" of the Articles of Incorporation of the Corporation is amended and restated in its entirety to read as follows:

"Article 3. Primary Purpose

The primary purpose-business of the Corporation is Management."

4. The Articles of Amendment were duly approved and unanimously adopted by the sole Director of the Corporation on Oct. 1, 2007. The sole Director recommended approval of the Articles of Amendment to the sole Shareholder.

6. The number of votes cast for approval of the Articles of Amendment by the Shareholders was sufficient for approval.

7. In all other respects, the Articles of Incorporation shall remain as they were prior to these Articles of Amendment being adopted.
