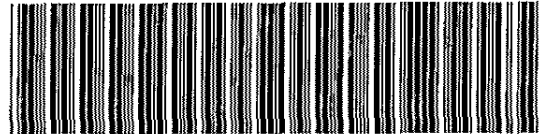

Pursuant to the provisions of section 607.1006, Florida Statutes, this corporation adopts the following Articles of Amendments to its Articles of Incorporation:

FIRST: Subparagraph 7.1 of Article 7 of the Articles of Incorporation of FLORIDA MULTIMEDIA DEVELOPMENT & HEALTHCARE SERVICES, INC. states:

The maximum number of shares that this Corporation is authorized to have outstanding at any time is **Ten Thousand (10,000)** shares of common stock, each having the par value of **ONE CENT (\$.01)**.

SECOND: Subparagraph 7.1 of Article 7 of the Articles of Incorporation of FLORIDA MULTIMEDIA DEVELOPMENT & HEALTHCARE SERVICES, INC. will be amended to state:

The maximum number of shares that this Corporation is authorized to have outstanding at any time is **Two Hundred Thousand (200,000)** shares of common stock, each having the par value of **One Cent (\$.01)**

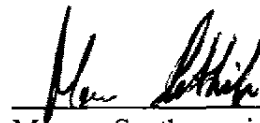
