ARTICLES OF INCORPORATION

OF

BOAR HOUSE BBQ, INC.

The undersigned incorporator, JOHN L. KONTOS, a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME

The name of this corporation is BOAR HOUSE BBQ, INC.

ARTICLE II - PRINCIPAL OFFICE
