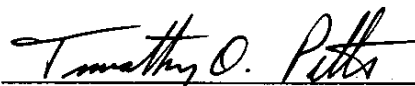
We are in receipt of your notice concerning Boar House BBQ, Inc.'s corporate annual report. As you requested, we return to you the annual report with Block 4 completed and the required \$150. annual fee.

In response to your request for additional funds, we feel that the taxpayer should not be required to pay the \$400. late charge. The corporation in question was formed in August of 2004, and still has not begun business. More importantly, no uniform business report was received by the corporation from the Florida Department of State before the initial filing deadline of May 1, 2005. Pursuant to Florida Statute 607.193(2)(b), this precludes the taxpayer from being subject to the late charge.
