ARTICLES OF INCORPORATION

<u>OF</u>

I, the undersigned, hereby make, subscribe, acknowledge and file these Articles for the purpose of forming a Corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of this Corporation shall be RAMATAP, INC.
