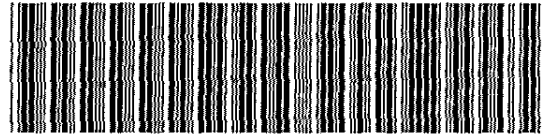

ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this Corporation is The Joshua Tree Nursery, Inc. and the physical and mailing address is 19925 CR 450, Umatilla, Florida 32784.

ARTICLE II - TERM OF EXISTENCE

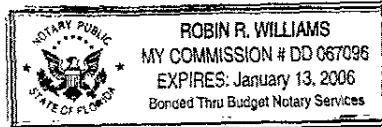
