**ARTICLES OF INCORPORATION**  
**OF**

The undersigned incorporator delivers these Articles of Incorporation in order to form a corporation under the Florida Business Corporation Act.

**ARTICLE I**  
**Name**

The name of the Corporation shall be NEW PELICAN, INC.

**ARTICLE II**  
**Principal Office**

The principal office of the Corporation is located at 1180 Spring Center South Boulevard, Suite 340, Altamonte Springs, Florida 32714, and its mailing address is the same.

**ARTICLE III**  
**Corporate Purposes, Power and Rights**
