ARTICLES OF INCORPORATION

OF

TIM EDWARDS OF DESTIN, INC.

The undersigned incorporator, TIMOTHY M. EDWARDS, a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Plorida Statutes.

ARTICLE I - NAME

The name of this corporation is TIM EDWARDS OF DESTIN, INC.

ARTICLE II - PRINCIPAL OFFICE

The street and mailing address of the principal office of the corporation is 20001-A Emerald Coast Parkway, Destin, Florida 32541.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business under the laws of the State of Florida and the laws of the United States.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue One Hundred (100) shares of \$1.00 par value common stock.

This corporation shall have perpetual existence.

ARTICLE VI - RESTRICTIONS ON TRANSFER OF STOCK

persons unless such shares are first offered to this corporation, and, if not so purchased, then to the other shareholders at the price and terms identical to the proposed sale to a third person. The restrictions contained in this Article VI may be modified by a separate written agreement among the corporation and the shareholders receiving shares in the initial issuance of stock of the corporation.

ARTICLE VII - INTITAL REGISTERED OFFICE AND AGENT
