ARTICLE I - NAME

The name of the corporation is: **WILSON'S TOWING INC.**

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The purpose or purposes for which the corporation is organized is to transact all lawful business for which corporations may be organized under the Florida Business Corporation Act of the State of Florida.

ARTICLE IV - STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is One Hundred (100) shares, all of which shall be common stock and the capital of the corporation, and additional stock may be issued by the Directors of the corporation for any consideration deemed advisable. Each share of common stock shall be valued at one (\$1.00) dollar per share.

**ARTICLE V - PREFERENCES, LIMITATIONS AND
RELATIVE RIGHTS OF SHARES OF COMMON STOCK**

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding Common Shares.

**ARTICLE VI - REGISTERED AGENT, INITIAL REGISTERED
OFFICE, MAILING ADDRESS AND INITIAL PRINCIPAL OFFICE**

The Registered Agent of this corporation shall be Marlyn Malagon, 1400 N. 74th Terrace Hollywood, FL 33024. The Initial Principal Office and Mailing Address of this corporation in the State of Florida shall be: 1400 N. 74th Terrace, Hollywood, FL 33024. The Board of Directors may, from time to time, move the principal office to any other address in Florida.

ARTICLE VII - DIRECTORS

This corporation shall have one (3) Director initially. The number of directors may be increased or diminished from time to time through the Bylaws adopted by the stockholders, but shall never be less than one (1).

The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Directors and the Shareholders.
