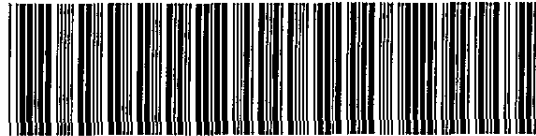

corporation Under the laws of the State of Florida:**

ARTICLE I

NAME:

ARTICLE II

PURPOSE:

**The corporation is organized to engage in any and all business
