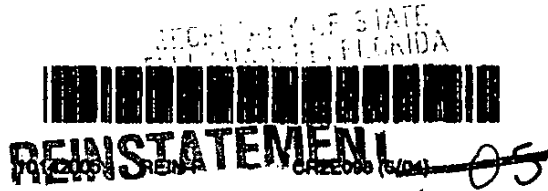

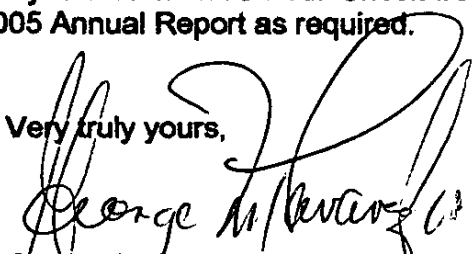
This Law Office filed the Articles of Incorporation for DUBB DUPLICATION, INC. on August 26, 2004, and was assigned document number P04000123669.
