

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following articles of incorporation:

## **ARTICLE I**

The name of this corporation shall be: John F. Thompson, Inc.

The duration of the corporation shall be perpetual.
