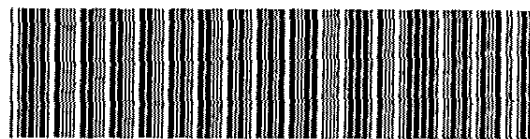

# ARTICLES OF INCORPORATION

OF

RJW FABRICATION, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

## ARTICLE I

The name of this corporation is **RJW FABRICATION, INC.**

## ARTICLE II

The existence of the corporation shall begin on August 23, 2004.

## ARTICLE III

The street address of the principal office of the corporation is 6113 Anderson Lane, Milton, Florida 32570.

## ARTICLE IV

The maximum number of shares this corporation is authorized to issue is ONE HUNDRED (100), par value ONE DOLLAR (\$1.00) per share, all of which shall be common shares. All common shares shall be identical with each other in every respect and the holders of common shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

## ARTICLE V

The Articles of Incorporation may provide that the corporation's existence begins on a date within five business days before the date of filing or a date after the filing date, if the date is specified in the Articles. In the absence of a specified date, the corporate existence begins when the Articles are filed pursuant to F.S. 607.0203(1).

## ARTICLE VI

Florida Statute 607.0301 permits a corporation to be organized for any lawful purpose or purposes. As a result, the Articles need not set forth corporate purposes.

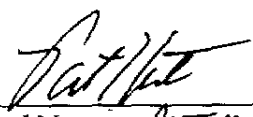
