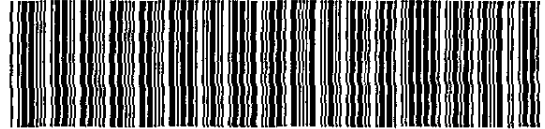

FEDERATION, INC.




THIRD: The Amendment was adopted by the Board of Directors on the 15<sup>th</sup> day of October, 2004.
