**ARTICLES OF INCORPORATION
OF

This undersigned incorporator, DEEBEE COMPANY, an individual authorized to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 500, Florida Statutes.

ARTICLE I - NAME
