PENNE ARY OF STATE WE, THE UNDERSIGNED, hereby associate ourselves together for the purpose of FLORIDA becoming a corporation under the laws of the state of Florida providing for the formation, liability, rights, privileges and immunities of corporations for profit.

ARTICLES L NAME
