The undersigned incorporator hereby executes these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State afiFlorida.

#### ARTICLE I: NAME

The name of the Corporation is Cherished Blossoms, Inc.

#### ARTICLE II: PRINCIPAL OFFICE
