Certificate of Incorporation of

The undersigned, acting as director(s) for the purpose of forming a corporation under and by virtue of the Laws of the State of Florida, adopt(s) the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be <u>Just Me Music of Sarasota Inc.</u> and its initial place of business shall be at <u>Westfield Shoppingtown Sarasota</u>, 8201 <u>Tamiami Trail</u>, in the City of <u>Sarasota</u>, in the County of <u>Sarasota</u> and State of Florida. ARTICLE II

The general nature of the business to be transacted by this corporation shall be to manufacture and sell Just Me Music personalized VeggieTale computer discs and other merchandise as authorized by Personalized Products/JustMeMusic, LLC a Tennessee company, having its principal place of business at 5123 Virginia Way, Suite C-11, Brentwood, Tennessee 37027.
