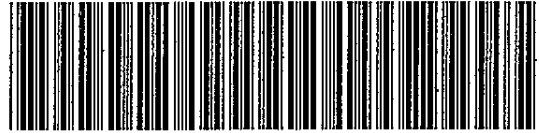

# Certificate of Incorporation of

## Just Me Music of Sarasota Inc.

The undersigned, acting as director(s) for the purpose of forming a corporation under and by virtue of the Laws of the State of Florida, adopt(s) the following Articles of Incorporation.

### ARTICLE I

The name of the corporation shall be Just Me Music of Sarasota Inc. and its initial place of business shall be at Westfield Shoppingtown Sarasota, 8201 Tamiami Trail, in the City of Sarasota, in the County of Sarasota and State of Florida. The corporation's mailing address is 6210 Medici Court #106, Sarasota, Florida 34243.

### ARTICLE II

The general nature of the business to be transacted by this corporation shall be to manufacture and sell Just Me Music personalized VeggieTale computer discs and other merchandise as authorized by Personalized Products/JustMeMusic, LLC a Tennessee company, having its principal place of business at 5123 Virginia Way, Suite C-11, Brentwood, Tennessee 37027. Global Retail Ventures, Inc., (Personalized Products sole representative), shall provide and implement its promotional, marketing, distribution, and software program, collectively referred to as the "GRV Program", which shall serve as the model program for Just Me Music of Sarasota Inc.

The foregoing purposes and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibiting the corporation from extending its activities to any related or otherwise permissible lawful business purposes which may become necessary, profitable, or desirable, for the furtherance of the corporate objectives expressed above.

### ARTICLE III

The total number of shares authorized to be issued by the corporation shall be (100) one-hundred. Such shares shall be of a single class and shall have a par value of \$ 100 per share. The corporation shall begin business with at least \$ 1,000 in paid-in common capital stock to be divided into (10) ten shares.

#### {Optional Preemptive Rights Clause:

Each shareholder of the corporation shall have the right to purchase, subscribe for, or receive a right or rights to purchase or subscribe for, at the subscription price offered to the general public, a pro rata portion of any stock of any class that the corporation may issue or sell.}
