ARTICLES OF INCORPORATION
OF

ARTICLE I.
NAME

The name of the Corporation is COOL-TEMP DESIGN CORP.

ARTICLE II.

The power to adopt, alter, amend or repeal the By-Laws shall be vested in the Directors.


ARTICLE XII.


