The undersigned, for the purpose of forming a corporation under the provisions of Chapter 607 of the *Florida Statutes*, hereinafter referred to as the Corporation, hereby agree to the following:

ARTICLE I Name and Address

The name of the Corporation shall be **Corpon D'Or-Gold Ribbon, Inc.** and its mailing address is 7312 Sixth Avenue North, St. Petersburg, Florida 33710.

ARTICLE II Purpose and Powers
