ARTICLES OF INCORPORATION

OF

We, the undersigned, each a natural person competent to contract, do hereby associate ourselves together for the purpose of forming a corporation for profit under the laws of the State of Florida, in accordance with the following Certificate of Incorporation.

ARTICLE I

The name of this corporation shall be **GREGG ROSS DEVELOPMENT, INC., A FLORIDA CORPORATION.**

ARTICLE II

The general nature of the business to be transacted by this corporation is Real Estate Development. To engage in any activities or business permitted under the laws of the United States and of this State, except that it shall not engage in the railroad, canal, telephone, or telegraph business.




