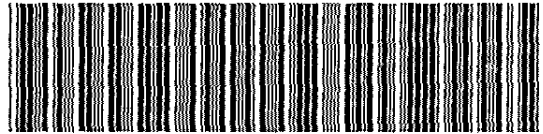



### ARTICLE I

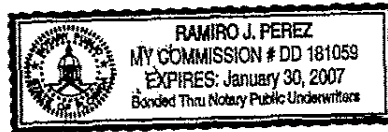
