AMENDMENT



PREEMPTIVE RIGHTS



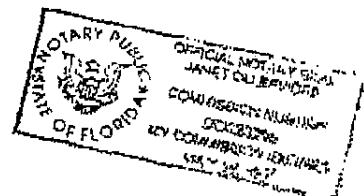
