The undersigned subscriber(s) to these articles of incorporation, being duly licensed to practice dentistry under the laws of the state of Florida, adopt(s) these articles to form a corporation under the Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621, and other laws of the state of Florida.

ARTICLE I – NAME

The name of the professional service corporation ("Corporation") is: GERALD B. RAMOS, D.D.S., P.A.

ARTICLE II – PRINCIPAL OFFICE

The principal office and mailing address of this Corporation are: 315 East Strawbridge Avenue, Melbourne, Florida 32901.

ARTICLE III – PURPOSE

The professional service corporation is formed to engage in every phase and aspect of the practice of dentistry. 
