ARTICLES OF INCORPORATION OF BLUE BAY INC.

ARTICLE I. NAME

The name of the corporation is Blue Bay, Inc.

ARTICLE II. DURATION AND COMMENCEMENT OF EXISTENCE

The corporation is to have perpetual existence, commencing at the filling of these articles with the Department of State.

ARTICLE III. PURPOSE

The corporation is organized for the purpose of transacting real estate investments and any and all lawful business.

ARTICLE IV. CAPITAL STOCK

The aggregate number of shares of stock which the corporation shall have authority to issue is One Thousand (1000) shares of common stock at a par value of One dollar (\$1.00) per share.
