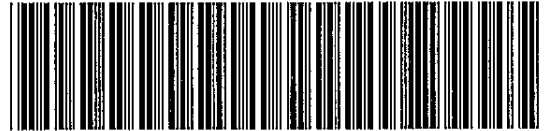


ARTICLE VII-BYLAWS
