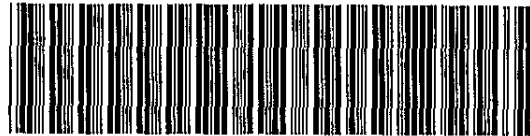

ARTICLE I - NAME

The name of this Corporation is C.D.S. HANDYWORKS & CONSTRUCTION, INC.


