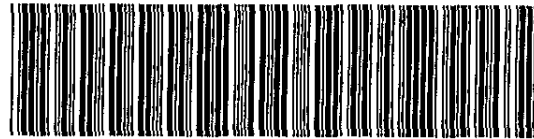



ARTICLES OF INCORPORATION

OF

KARL SYKTICH, INC.

ARTICLE I • NAME

The name of this Corporation is Karl Syktich, Inc. The principal office and mailing address is 5951 N.W. 47th Terrace Coconut Creek, FL. 33073.

ARTICLE II • DURATION

This Corporation shall exist perpetually commencing on the date these Articles are filed.

The power to adopt, amend, alter, rescind or repeal the By-laws shall be vested in the Board of Directors and the shareholders.


ARTICLE X • POWERS


