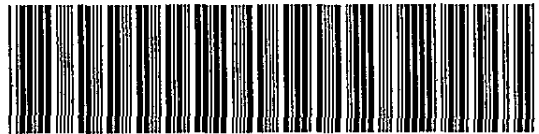



BY THESE ARTICLES OF INCORPORATION, the incorporator forms a corporation for profit under Florida Law.
