

## ARTICLES OF INCORPORATION

The name of the Corporation is Plantation Lake Academy Alternative Article I. Name. Private School System, Inc.

Article II. Principal Office.

15 St. Johns Medical Park, St. Augustine, FL 32086

Article III. Purposes. The purpose of the corporation is as follows:

A. This corporation is a corporation organized under Chapter 621, Florida Statutes. The specific purposes of this corporation are organized for religious educational purposes, which include, but are not limited to: (1) The establishment and operation of an independent private system of Christian elementary and secondary schools in St. Johns County, Florida and the major area thereof.
