



ARTICLES OF CORRECTION FOR

NATURAL LOOK CORPORATION

Pursuant to the provisions of Section 607.0124, Florida Statutes, the undersigned does hereby adopt the following Articles of Correction to correct the Articles of Incorporation originally filed with the Department of State on September 2, 2004, a copy of which are attached.

The Articles of Incorporation contain an inaccurate statement, found in Article IV, which states:

"ARTICLE IV:

The number of shares the corporation is authorized to issue is: 10,000"

This statement is incorrect because the number of authorized shares is 100,000, not 10,000. The statement is incorrect due to a clerical drafting error.

Article IV should read as follows:

"ARTICLE IV:

The number of shares the corporation is authorized to issue is: 100,000"
