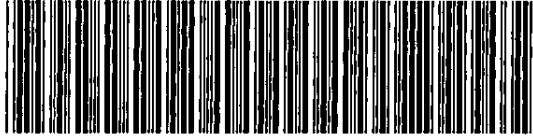

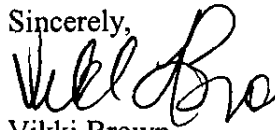

Pursuant to the provisions of the Section 607.1006 and 621.04 of the Florida Statutes, this Florida Corporation adopts the following articles of amendment to its articles of incorporation:

- 1) NEW CORPORATE NAME: JAMES MICHAEL CONFORTI, P.A.
- 2) CORPORATION PURPOSES, POWERS & RIGHTS: The nature of the business to be conducted or promoted and the purposes of the corporation is to engage in the practice of REAL ESTATE and any lawful act or activity for which a professional service corporation engaged in such profession may be organized under the Professional Service Corporation Act and Limited Liability Company Act (AAct@), and in which such a corporation is permitted to engage under applicable law. In furtherance of its corporate purposes, the corporation shall have all the general and specific powers and rights granted to and conferred on a corporation by the Act.
- 3) AFFIRMATION: IT IS HEREBY AFFIRMED THAT THE SHAREHOLDERS HAVE ELECETED TO BRING THE CORPORATION WITHIN THE PROVISIONS OF CHAPTER 621 OF THE FLORIDA STATUTES.
