The undersigned, acting as incorporator of a corporation under the Florida

General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME. The name of this corporation is JT HOME INSPECTOR, INC

or periods and upon such terms and conditions as may be determined from time
to time by the Board of Directors.
