

ARTICLES OF AMENDMENT JALLAHASSES, FLORIDA

ARTICLES OF INCORPORATION

OF

SILVER NICKEL INVESTMENTS, INC.

Pursuant to the provisions of Sections 607.1005 and 607.1006 of the Florida Business Corporation Act, Silver Nickel Investments, Inc., a Florida corporation (the "Corporation"), whose Articles of Incorporation were originally filed with the Florida Department of State on September 2, 2004, adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I Name

The name of the corporation is Silver Nickel Investments, Inc.

ARTICLE II Amendment

Article I of the Articles of Incorporation of the Corporation shall be amended in its entirety to read as follows:

"ARTICLE I Name

The name of the corporation is Bordwell Investments, Inc."

ARTICLE III Date of Adoption

The amendment was adopted by the Corporation's sole incorporator prior to the issuance of any common capital stock of the Corporation on November 22, 2004.

ARTICLE IV Manner of Adoption

The amendment was duly approved by the sole incorporator without shareholder approval prior to the issuance of any of the common capital voting or nonvoting shares of the Corporation pursuant to Section 607.1005, Florida Business Corporation Act; and approval of the stockholders was not required.
