ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

ARTICLE I

NAME AND ADDRESS

Section 1.1 Name. The name of the corporation is THE BENZ STORE, INC.

Section 1.2 Address of Principal Office. The address of the principal office of the corporation is 5105-502 Philips Highway, Jacksonville, Florida 32207.

DURATION

Section 2.1 Duration. This corporation shall exist perpetually. 
ARTICLE IX


