# ARTICLES OF INCORPORATION OF THE BENZ STORE, INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

## **ARTICLE I**

### NAME AND ADDRESS

Section 1.1 Name. The name of the corporation is THE BENZ STORE, INC.

Section 1.2 <u>Address of Principal Office</u>. The address of the principal office of the corporation is 5105-502 Philips Highway, Jacksonville, Florida 32207.

#### ARTICLE II

#### DURATION

Section 2.1 <u>Duration</u>. This corporation shall exist perpetually. # ARTICLE III

### **PURPOSES**

Section 4.1 <u>Authorized Capital</u>. The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is 10,000 shares of voting common stock having a par value of \$.01 per share.
