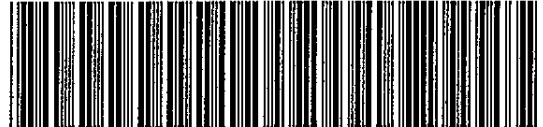



The undersigned incorporator hereby executes these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I: NAME

The name of the Corporation is MVP Consulting, Inc.

ARTICLE II: PRINCIPAL OFFICE

The principal place of business is 5022 Sunset Blvd., Port Richey, Florida 34668 and mailing address of this corporation shall be 4532 W. Kennedy Blvd., #168, Tampa, Florida 33609.

ARTICLE III: CAPITAL STOCK

The aggregate number of shares of capital stock authorized to be issued by this corporation shall be 100 shares of common stock with a par value of \$1.00 per share. Each share of said stock shall entitled the holder thereof to one vote at every annual or special meeting of the stockholders of this corporation. The initial registered office of this corporation shall be 5022 Sunset Blvd., Port Richey, Florida 34668 and the initial registered agent of this corporation at such office shall be Jarrett Preston. This corporation shall have the right to change such registered agent and such registered office from time to time, as provided by law.

ARTICLE V: BOARD OF DIRECTORS

The Board of Directors of this corporation shall consist of a number of directors to be fixed from time to time by the stockholders or the by-laws. The number of directors may be raised or lowered by amendment of the bylaws, but shall in no case be lower than one. The term of existence of this corporation is perpetual.


ARTICLE IX: BY-LAWS


