ARTICLES OF INCORPORATION

OF

ORANGEPARK.COM, INC.

Pursuant to the provisions of Chapter 607, Florida Statutes, as amended, the following are hereby adopted and filed as the Articles of Incorporation of this Florida corporation for profit:

ARTICLE I - NAME

The name of this Corporation shall be: orangepark.com, Inc.

ARTICLE II - INITIAL PRINCIPAL OFFICE

Said consideration is to be paid in cash or other property, tangible or intangible, or in labor or services actually performed for the Corporation.

ARTICLE VI - INITIAL REGISTERED AGENT AND OFFICE

This Corporation shall have three (3) Directors initially. The number of Directors may be either increased or decreased from time to time but shall never be less than one (1).
