

The undersigned incorporator hereby executes and acknowledges these Articles of Incorporation for the purpose of forming a corporation for profit under and by virtue of the laws of the State of Florida as contained in the Florida Business Corporation Act, Chapter 607, *Florida Statutes*, and the Professional Service Corporation and Limited Liability Company Act, Chapter 621, *Florida Statutes*.
