I.

The name of the Corporation is A & A NATURAL FOODS COMPÄNY, INC.

II.

None of the member of the Board of Directors shall be personally liable for monetary damages to the corporation or any other person for any statement, vote, decision, or failure to act, regarding corporate management or policy, by a director, unless: (a) The director breached or failed to perform his or her duties as a director; and (b) The director's breach of, or failure to perform, those duties constitutes: (i) A violation of the criminal law, unless the director had reasonable cause to believe his or her conduct was lawful or had no reasonable cause to believe his or her conduct was unlawful; (ii) A transaction from which the director derived an improper personal benefit, either directly or indirectly; (iii) A circumstance under which the liability provisions of s.607.0834 are applicable; (iv) a proceeding by or in the right of the corporation to procure a judgment in its favor or by or in the right of a shareholder, conscious disregard for the best interest of the corporation, or willful misconduct; or (v) In a proceeding by or in the right of other than the corporation ora shareholder, recklessness or an act or omission which was committed in bad

faith or with malicious purpose or in a manner exhibiting wanton and willful disregard of human rights, safety, or property.
