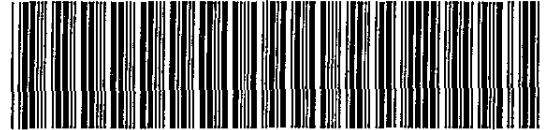

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is: GILBERT AND STEFANO'S DELI, INC..

ARTICLE II

The street address of the principal office of the Corporation is: 755 NE 43RD STREET, OAKLAND PARK, FL 33334.

ARTICLE III

The maximum number of shares this Corporation is authorized to issue is 1,000, par value \$.01 per share, all of which shall be Common Shares. 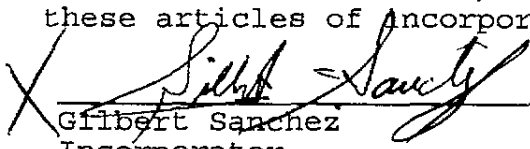

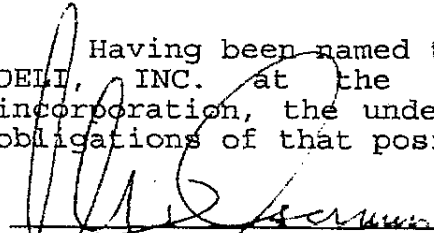

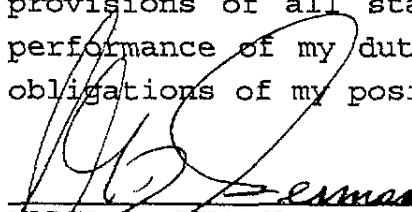
