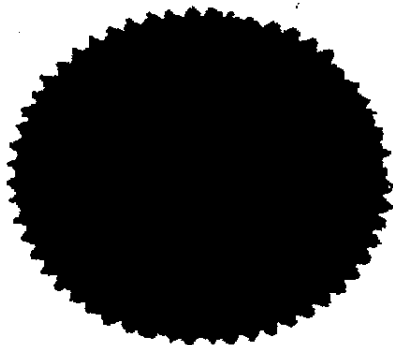

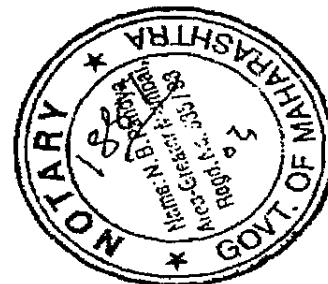

**ARTICLES OF INCORPORATION OF

1. ARTICLE I Name.

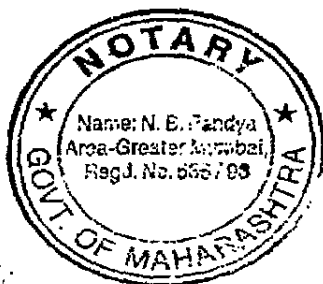

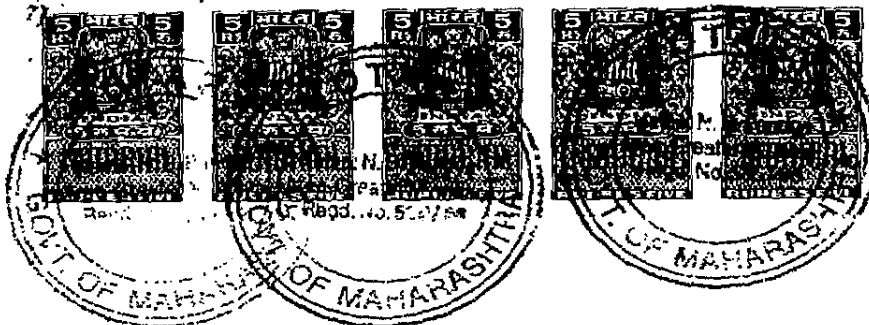
