Initial Board of Directors



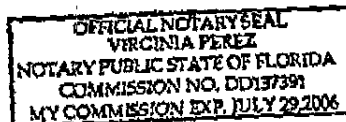


