## The Villas at Emerald Dunes Corp. A Florida Corporation

The undersigned, pursuant to the provisions of Chapters 607 and 621 of the Florida Statutes, for the purpose of forming a corporation under the laws of the State of Florida set forth the following:

#### **ARTICLE I: NAME**

The name of the corporation is The Villas at Emerald Dunes Corp., a Florida corporation (the "Corporation").

#### ARTICLE II: ADDRESS OF PLACE OF BUSINESS
