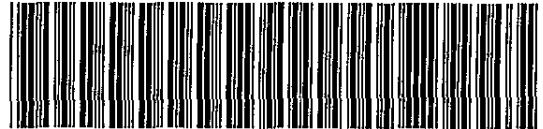

**ARTICLE I - NAME**

The name of this corporation is **MANRAVAL INC.**
