ARTICLES OF INCORPORATION

The undersigned, Darrin R. Schutt, Esq., files in the Office of the Secretary of State of the State of Florida, for the purpose of forming a corporation/professional association for profit, in accordance with the laws of the State of Florida, these Articles of Incorporation, as by law provided.

I. NAME:

The name of this Corporation shall be: JEFF PACE, RA.

II. BUSINESS:

The general nature of the business and business to be transacted are as follows: To provide professional services in the nature of real estate and other related real estate services, under the laws and applicable regulations of the State of Florida of the United States.
