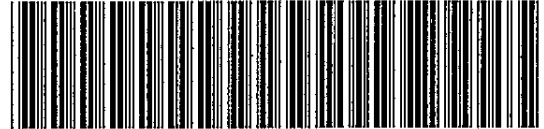

**ARTICLES OF INCORPORATION
OF
METRO MORTGAGE AND FINANCIAL SERVICES, INC.**

TO THE SECRETARY OF STATE OF THE STATE OF FLORIDA;

I, the undersigned, desiring to become a body corporate in compliance with Chapter 607 and/or Chapter 621, F.S. (Profit), for the purpose hereinafter stated and set forth, do hereby file in the office of the Secretary of State of Florida this, my Certificate of Incorporation, in accordance with the laws of the State of Florida, and I do hereby set forth and certify as follows:

**ARTICLE I
NAME**

The name of the corporation shall be **METRO MORTGAGE AND FINANCIAL SERVICES, INC.**

**ARTICLE II
PRINCIPAL OFFICE**

The street and mailing address of the principal place of business of this corporation shall be 4307 E. Colonial Drive, Orlando, FL 32803

**ARTICLE III
PURPOSE**

The purpose for which this corporation is organized is to engage or transact in any and all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation, including all powers necessary or convenient to effect its purpose.

**ARTICLE IV
SHARES**

The number of shares of stock the corporation is authorized to issue shall be One Thousand (1,000) shares of common stock with a par value of \$1.00 per share. When the common stock of the corporation is issued and paid for, the common stock so issued shall be stamped "FULLY PAID AND NON-ASSESSABLE."

**ARTICLE V
PRE-EMPTIVE RIGHTS**

Except as may otherwise be provided by the Board of Directors, no holder of any shares of the stock of the corporation shall have any pre-emptive rights to purchase, subscribe for or otherwise acquire any shares of stock of the corporation, or any securities exchangeable for or convertible

into such shares, or any warrants or other instruments evidencing rights or options to subscribe for, purchase or otherwise acquire such shares.

ARTICLE VI STOCK RIGHTS AND OPTIONS

The Corporation shall have the power to create and issue rights, warrants, or options entitling the holders thereof to purchase from the corporation any shares of its capital stock, upon such terms and conditions and at such times and prices as the Board of Directors may provide, which terms and conditions shall be conclusive.
